

SAGE had a record year in 2024. We hit major milestones on our projects, like the Anpetu Wi Wind Farm and the Electric Vehicle (EV) Charging Network. We took significant steps toward our next generation of projects. We presented and participated at numerous events, made headlines across the region, and achieved historic milestones in energy ownership. But what I'm most proud of isn't what we've done; it's how we've done it.

SAGE represents a new phase as the Standing Rock Nation shifts from economic exclusion to energy ownership. Our community takes part in every step of our visioning, planning, and action processes because we know how important it is for our community. We partner with our young people, guided by our Elders' wisdom, to embrace this next phase of self-determination for Standing Rock, and allow what we're doing with SAGE to inspire our people in every aspect of their lives.

You'll notice throughout this report that we've placed an asterisk next to grants secured in 2024 that are now at risk. In the face of new obstacles, we are more committed than ever to bringing our vision to life as we remain steadfast in our commitment to renewable energy and seeing our Standing Rock Nation thrive.

We are grateful to our partners for joining us on our mission, and we look forward to everything we can accomplish together.

## **Anpetu Wi Wind Farm**

#### **Phase** Pre-Development

SAGE's inaugural utility-scale project at 235 MW, the Anpetu Wi Wind Farm, is a landmark project in our commitment to clean energy, job creation, and economic prosperity within the region. This project is poised to become the first and only utility-scale Native-led wind farm in the United States. With a historic Developer Service Agreement (DSA) that enables Standing Rock to retain ownership and maximize revenue of the wind farm. Anpetu Wi is a transformative energy project paving the way for other communities. The wind farm is also anticipated to produce 988,128 MWh of renewable energy per year, equivalent to 136 thousand homes' electricity use for 1 year.



SAGE enters into groundbreaking **Developer Service Agreement** for Anpetu Wi Wind Farm

### The Developer Partnership Reimagined

Anpetu Wi has drafted a groundbreaking contract with a major developer to enter into a fee-for-services agreement that will maintain SAGE's position as the owner of Anpetu Wi. The agreement also includes a workforce development Memorandum of Understanding (MOU) that codifies our commitment to bringing jobs and economic growth to our community. This agreement positions SAGE to retain unprecedented ownership, governance, and revenue from Anpetu Wi. This revenue will enable SAGE to be a lead investor in our future projects.

The interconnection process—the procedure by which energy projects connect to the physical energy grid-remains one of the most significant barriers for community-led projects. This process requires large financial security deposits to remain in good standing with the interconnection queue, often with only 15 days' notice. These financial hurdles, coupled with complex technical requirements, create substantial challenges for frontline communities seeking to develop and own energy assets.

With the support of our partners, SAGE has successfully navigated the Southwest Power Pool (SPP) interconnection queue since 2020 and remains in good standing with all financial and non-financial benchmarks met.

SAGE has enlisted Baker Tilly to serve as the project manager for land control strategy, Nexus Energy Solutions to secure fee land leases, Bartlett and West to assist with Allotted and Tribal Trust Land control, Dentons and Stoel Rives as legal counsel to draft lease agreements. In 2024, SAGE obtained over 80% of the private land needed in the Area of Interest.

SAGE has contracted Simon Wind to analyze wind data and improve project planning. In the past year, we have measured long-term wind speeds with Met Mast Towers (MMT) to refine turbine placement strategies, and complete a preliminary wind assessment for turbine arrays.

## **Single Wind Turbine**

#### Phase Pre-Development

The installation of a 1.7-5.0 MW Single Wind Turbine will provide a substantial portion of the Standing Rock Nation's electricity load while accelerating our transition to renewable energy, advancing Standing Rock's energy self-determination and resilience goals, and subsidizing energy costs for Elders.

Over the life of the project, the Single Wind Turbine will prevent the release of nearly 6 million pounds of  $CO_2$ , which is the equivalent of around 3 million pounds of coal burned or 500 homes' electricity use for 1 year.



## **Electric Vehicle Charging Network\***

#### Phase Installation

This past year, SAGE unveiled its inter-Tribal EV Charging Network partnerships and showcased the vehicles delivered to the Standing Rock Nation as part of the \$13.4M Electric Nation project. Electric Nation is a Native Sun Community Power Development project in partnership with SAGE and the American Lung Association to implement the Upper Midwest Inter-Tribal EV Charging Community Network.

This project will provide a broader charging network that runs from Red Lake, MN, to Standing Rock, ND, with plans to expand into other Native Nations across rural Minnesota, North Dakota, and South Dakota. As part of this work, SAGE has installed a total of 7 electric charging stations across the Standing Rock Nation.





## **Community Solar Network\***

#### Phase Installation

These installations are the first steps in a community-scale solar project aimed at integrating sustainable energy solutions across all 8 districts of the Standing Rock Nation.

In 2024, SAGE completed the installation of 10 solar arrays strategically located across the Nation at community and Headstart buildings. Targeting these locations will directly provide revenue savings to communities to redistribute to our programs. With these solar arrays in place, these strategic locations can spend money that would have gone toward electric bills on key initiatives.

SAGE launched a paid apprenticeship program to coincide with the solar installations in a powerful commitment to community empowerment and sustainable growth. This initiative is designed to equip community members with essential skills and create job opportunities within the renewable energy sector. These installations have provided 6 paid apprenticeships with opportunities to work on additional projects within the region.



## Details

### Impacts

- Installs photovoltaic (PV) systems, also known as solar arrays, to generate total of 100kW of solar energy on 10 district and headstart buildings
- Allows key organizations to spend their funding on important programing instead of electricity bills
- Provides workforce development for apprentices to develop solar installation skills
- Installed 10 10kW solar arrays at 10 key locations across Standing Rock
- Created 6 paid apprenticeships as solar installers for Standing Rock community members
- Installed solar arrays on 7 out of 8 district buildings and 2 out of 7 Headstart buildings, a significant benchmark on our road to energy self-sufficiency

## Next Steps in 2025

- Apply for Elective Pay Investment Tax Credits to increase revenue and reinvest in SAGE projects
- Continue community solar installations across remaining districts
- Explore funding opportunities as they become available

## **Workforce Development**

### 

Through fostering talent and providing hands-on experience, SAGE is dedicated to nurturing a robust workforce for the future of sustainability in Standing Rock and in the region. In addition to the community solar apprenticeships and the workforce development MOU for Anpetu Wi, SAGE is creating a curriculum for workforce development related to renewable energy. It's one more example of how we are using renewable energy projects as a way to bring economic growth to Standing Rock and beyond.
